**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - Name of Corporation

The name of this corporation shall be: Physicians Guaranteed Trust, Inc.

ARTICLE II - Duration

The term of existence of the corporation is perpetual, commencing upon the filing of these Articles of Incorporation with the Department of State, State of Florida.

ARTICLE III - Purpose and Powers

The corporation may transact any and all lawful business for which corporations may be incorporated under Florida General Corporation Act, as in effect from time to time. The corporation shall have all the powers set forth in said Act, as in effect from time to time.

ARTICLE IV - Capital Stock

The Aggregate number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is Seventy-Five Hundred (7500) shares of common stock, each having a par value of One dollar (\$1.00) per share.

ARTICLE V - Preemptive Rights Granted

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquire shares of any such unissued or treasury shares.

ARTICLE VI - Registered Office

The street address of the initial registered office of the corporation is : 2207 Belchery Court, Clearwater, FL 34624, and the name of the initial registered agent at that address is Surindar S. Bedi.

ARTICLE VII - Directors

This corporation shall not have less than one director initially. The number of directors may be increased or diminished from time to time through Bylaws adopted by the shareholders.

The initial director shall be Surindar S. Bedi.
