ARTICLES OF INCORPORATION

OF

SONGBOK, INC

(a Corporation for Profit)

The undersigned, acting as incorporators of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I -NAME

The name of the Corporation shall be SONGBOK, INC.

ARTICLE II- TERM OF EXISTENCE

The period of duration of the Corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS

The purpose for which the Corporation is organized is to do all things that are not forbidden by the Florida Corporation Laws or by other laws or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not fobidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

ARTICLE IV - CAPITAL STOCK

Number. The aggregatge number of shares that the Corporation shall have the authority to issue is 1000 shares of Capital Stock with a par value of \$1,00 per share.

Stated Capital. The sum of the par value of all shares of Capital Stock of the Corporation that have been issued shall be the stated capital of the Corporation at any particular time.

Dividends. The holder(s) of the outstanding Capital Stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the Capital Stock of the Corporation.

ARTICLE V - ADDRESS

The initial street address in Florida of the initial registered office of the Corporation is 2204 S W 13th Street, Gainesville, Fl 32608, and the name of the initial registered agent is SONG K CHOE and his signature below connotes acceptance of this designation.

ARTICLE VI - DIRECTORS

The initial Board of Directors and Officers shall consist of three(3) members, who needs not be a resident of the State of Florida or a Shareholder or the Corporation.
