

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation pursuant to Chapter 621, Florida Statutes, do hereby adopt the following Articles of Incorporation:

EFFECTIVE DATE

5-9-97

ARTICLE I. NAME

The name of this corporation is Betty Wendt Mayer, ARNP, PA

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing as of the effective date listed in these Articles of Incorporation.

ARTICLE III. GENERAL PURPOSE

The purpose for which this corporation is initially organized is to engage in every aspect of the business of rendering the same professional services to the public that an Advanced Registered Nurse Practitioner, duly licensed under the laws of the State of Florida, is authorized to render. This corporation may engage or transact in any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having no par value per share.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash or any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others, which price, in the case of par value shares, may be in excess of par.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The corporation shall indemnify its officers, directors and authorized agents for all liability incurred directly, indirectly or incidentally to services performed for the corporation, to the fullest extent permitted under the Florida law existing now or hereinafter enacted.

ARTICLE XII. EFFECTIVE DATE

These Articles of Incorporation are to be effective as of May 9, 1997.

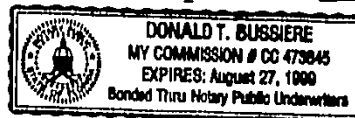
