ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a TALL STATE corporation pursuant to Chapter 621, Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

5-9-97

The name of this corporation is Betty Wendt Mayer, ARNP, PA

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing as of the effective date listed in these Articles of Incorporation.

ARTICLE III. GENERAL PURPOSE

The purpose for which this corporation is initially organized is to engage in every aspect of the business of rendering the same professional services to the public that an Advanced Registered Nurse Practitioner, duly licensed under the laws of the State of Florida, is authorized to render.
