The undersigned, acting as Incorporators of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is RAMPART ENGINEERING SERVICES, INC., a Florida corporation.

2. **Principal Office/Mailing Address.** The principal office of the corporation is 10033 9th Street North, Second Floor, St. Petersburg, Florida 33716-3805. The mailing address of the corporation is 10033 9th Street North, Second Floor, St. Petersburg, Florida 33716-3805.

3. **Existence and Duration.** This corporation shall begin existence on the date of execution and acknowledgment of these Articles of Incorporation and shall have perpetual existence.

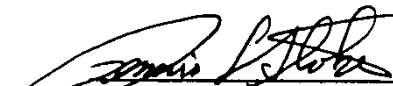
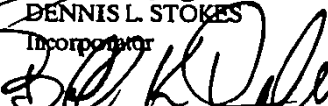

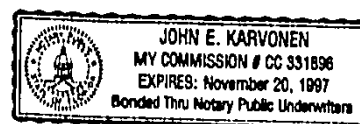
