The undersigned, for the purpose of forming a corporation under the General Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the corporation is Patriot Recycling & Transfer Inc.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

The purpose for which this corporation is organized is for any lawful business for which corporations may be incorporated under Florida General Corporation Act.
