the the Florida General Corporation Act, adopt the following Articles
of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is A.S.K Solutions, Inc.

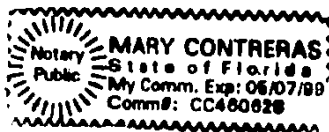
