ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I Name and Address

The name of the Corporation shall be TARIFF ADVISORY GROUP, INC. and its mailing address is 9269 Park Boulevard, Seminole, Florida 33777.
