ARTICLES OF INCORPORATION KEELY CONSULTING SERVICES, INC.

THE UNDERSIGNED subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Ι

The name of this corporation shall be KEELY CONSULTING SERVICES, INC. and the principal place of business shall be 5000 EAST LAKES DRIVE, POMPANO BEACH, FLORIDA 33064.

II
