ARTICLES OF INCORPORATION

The undersigned, Kenneth A. Stanley, natural person competent to contract, does hereby make, subscribe and file these Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation shall be:

FINASTA INDUSTRIES, CORP.

ARTICLE II

NATURE OF CORPORATE BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation shall be to engage in any and all lawful business permitted under the laws of the United States and the State of Florida, specifically but not limited to marketing, and selling equipment/vehicle wash water pre-treatment to sewer systems and equipment/vehicle wash water recycling systems.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time shall be TEN MILLION (10,000,000) shares of common stock having a par value of .00001 per share.

ARTICLE IV

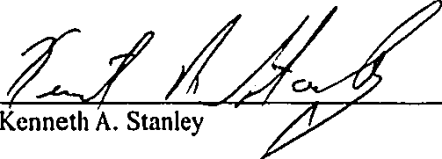
ARTICLE VII

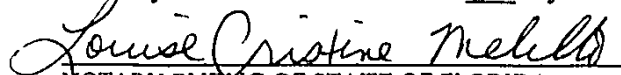

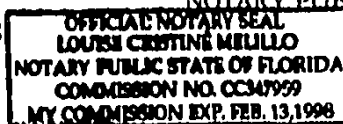
