**ARTICLE I - NAME**

The name of this Corporation is TREAT CENTERS USA OF ST. PETERSBURG, INC. and its address is 3990 Sheridan Street, Hollywood, Florida 33021.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


#### ARTICLE IX - INCORPORATOR
