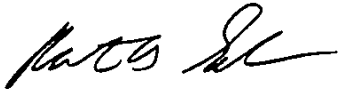

ARTICLES OF INCORPORATION

OF

JONATHAN D. SCHUMAN, P. A.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and, an Attorney At Law, duly licensed to render services as such under the Laws of the State of Florida, hereby presents these Articles for the formation of a corporation under the Professional Service Corporation and Limited Liability Company Act, and other laws of the State of Florida.

ARTICLE I. NAME: The name of the Corporation is Jonathan D. Schuman, P. A.

ARTICLE II. NATURE OF BUSINESS AND PURPOSE: The general nature of the business to be transacted by the Corporation is:

A. To engage in every phase and aspect of the business of rendering the same professional services to the public that an Attorney At Law, duly licensed under the Laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the Laws of the State of Florida to practice as an Attorney At Law therein.

B. To invest the funds of the Corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and to own real and personal property necessary for the rendering of professional services.

C. To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the Corporation, and in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or attainment of the objects or the furtherance of such purposes or objects of the Corporation.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the Corporation, and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the Corporation otherwise permitted by law.

ARTICLE III. CAPITAL STOCK: The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is Five Hundred (500) shares of common stock having a par value of One (\$1.00) Dollar per share. None of the shares of the Corporation may be issued to anyone other than an individual duly licensed to practice as an Attorney At Law in the State of Florida.

ARTICLE IV. INITIAL CAPITAL: The amount of capital with which the Corporation will begin business is Five Hundred (\$500.00) Dollars.

ARTICLE V. TERM OF EXISTENCE: The Corporation is to exist perpetually.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT: The street address of the initial registered office of this corporation is 7519 Alpha Court, East, West Palm Beach, Florida 33406, and the name of the initial registered agent of this Corporation at that address is Jonathan D. Schuman.

ARTICLE VII. VOTING RIGHTS: Except as otherwise provided by law, the entire voting power for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

ARTICLE VIII. INITIAL BOARD OF DIRECTORS: This corporation shall have one (1) director initially. The number of directors may be either increased or diminished from time to time by the by-laws, but shall never be less than one (1). The name and address of the initial director of this Corporation is as follows: Jonathan D. Schuman.

ARTICLE IX. The name and address of the person signing these Articles of Incorporation as subscriber, an Attorney At Law, duly licensed under the Laws of the State of Florida to render services as such, is:

ARTICLE X. VOTING TRUSTS: No stockholder of the Corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his shares.

ARTICLE XI. RESTRAINT ON ALIENATION OF SHARES: The stockholders of the Corporation shall have the power to include in the by-laws adopted by a two-thirds majority of the stockholders of the Corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding stock of the Corporation by any of its stockholders, or in the event of the death of any of its stockholders. The manner and form, as well as the relevant terms, conditions and details thereof, shall be determined by this stockholders of the Corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice thereof, unless the existence of such provisions shall be plainly written upon the certificate evidencing the ownership of such stock. No stockholder of the Corporation may sell or transfer his stock therein except to another individual who is eligible to be a stockholder of the Corporation, and such sale or transfer may be made only after the same shall have been approved at a stockholder's meeting specially called for such purpose. If any stockholder becomes legally disqualified to practice law in the State of Florida, or accepts employment that places restrictions or limitations upon his continuous rendering of such professional services, such stockholder's shares of stock shall immediately become subject to purchase by the Corporation in accordance with the by-laws adopted by the stockholders.

ARTICLE XII. PRE-EMPTIVE RIGHTS: Every stockholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE XIII. AMENDMENT: This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the stockholders is subject to this reservation.
