ARTICLES OF INCORPORATION OF A-BETR-LIFE, INC. 97 MAY 15 AM 9:02

ARTICLE I

The name of this corporation shall be as follows: A-BETR-LIFE, INC., and the initial principal office of this Corporation shall be: 2873 SOUTH UNIVERSITY DRIVE, DAVIE, FLORIDA 33328.

ARTICLE II

The commencement of existence of the corporation shall be the date of filing.

ARTICLE III

The general nature of the business and objects and purposes proposed to be transacted and carried on by this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might do, viz:
