

ARTICLE I

The name of the corporation is CAMEO CONSTRUCTION MARKETERS, INC..

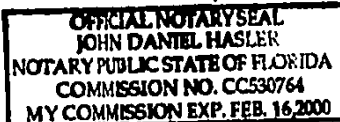

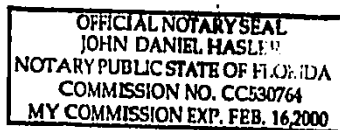
