#### ARTICLES OF INCORPORATION

OF

#### SOUTHERN EXPOSURE DEVELOPMENT COMPANY

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

# ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the Corporation shall SOUTHERN EXPOSURE DEVELOPMENT COMPANY, a Florida corporation. The street address of the initial principal office of the Corporation is 435 10th Avenue West, Palmetto, Florida 34221. The Corporation's mailing address is P. O. Box 277, Palmetto, Florida 34221.

#### ARTICLE II - PURPOSE AND POWERS

Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.

Section 2. The Corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.

#### ARTICLE III - DATE OF COMMENCEMENT AND TERM OF EXISTENCE
