The date of the amendment's adoption: May 2, 2007.

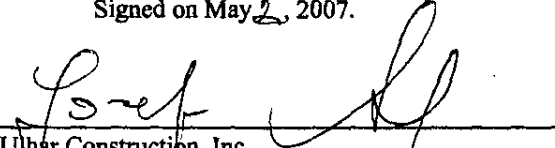
**SECOND:** Amendment adopted: The general nature of the business to be transacted by this corporation is to engage in construction related enterprises along with providing accounting services.

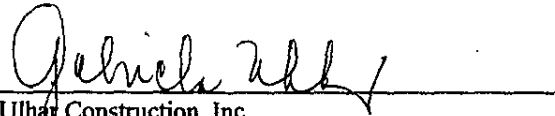
