ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be Arch-Golf, Incorporated.

ARTICLE II

- A. To carry on and conduct any lawful business in the State of Florida, including but not limited to the business playing in professional golf tournaments, teaching golf, and marketing and repair of golf items.
- B. The nature of business shall be deemed to include all the rights, powers and privileges now afforded by the laws of the State of Florida, and such rights as may hereafter be extended by the laws of Florida to corporations for profit.

ARTICLE III
