ARTICLES OF INCORPORATION

OF

JANSTER CREATIONS, INC.

ARTICLE I - NAME

The name of this incorporation is JANSTER CREATIONS, INC. The mailing address of this Corporation is 12612 Coral Lakes Drive, Boynton Beach, Florida 33437.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE VIII - BY-LAWS

The power to adopt, alter, amend, or repeal bylaws shall be vested in the Board of Directors and the Shareholders.
