ARTICLE I - NAME

The name of this corporation is **TREASURE COAST ARCHITECTS & ENGINEERS,
PLANNERS & DESIGNERS INC.**

ARTICLE II - PURPOSE

This corporation is organized for the purpose of design, development, management and related matters.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of one dollar (\$1.00) par value common stock, which shall be designated "Common Shares".


