#### ARTICLES OF INCORPORATION

OF

GULFTEK, INC.

#### I. NAME

The name of the corporation is GULFTEK, INC.

## II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

#### III. NATURE OF BUSINESS
