The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

ARTICLE 1- NAME

The name of this corporation is JOYCAS, INC.

ARTICLE 2- PRINCIPAL OFFICE

The street address of the initial principal office of the corporation shall be: 2926 N State Road 7, Lauderdale Lakes, FL 33313.

ARTICLE 3- PURPOSE

The corporation is organized for the purpose of sales of beauty supplies or in any activity that is lawful in this state or the United States.

ARTICLE 4- CAPITAL STOCK


