ARTICLES OF INCORPORATION

OF

ALAN J. POLLOCK, P.A.

The undersigned natural person, who is licensed or otherwise legally authorized to practice the profession of Law on the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation shall be: **ALAN J. POLLOCK, P.A.** The address of the principal office of this corporation shall be 1701 W. Hillsboro Blvd., Suite 207, Deerfield Beach, Florida 33442, and the mailing address shall be the same.

ARTICLE II - NATURE OF BUSINESS

The purpose of the Corporation is:

A. To engage in the practice of law as a professional law corporation and to carry on services incident thereto. The practice of Law is the sole and exclusive professional service to be rendered by the corporation.

B. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
