The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE ONE: NAME

The name of the corporation is **Covan of Jacksonville, Inc.**

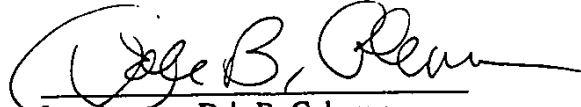

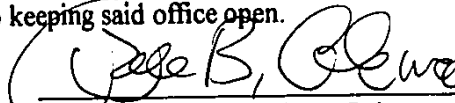
