ARTICLE I - NAME

The name of this corporation is: Emerald Green Taxi, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State.

The corporation is authorized to transact any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.


