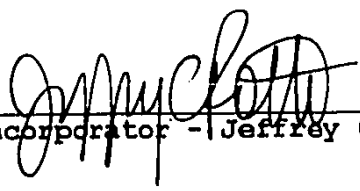
The corporation shall indemnify any officer or director or any former officer or director, to the fullest extent permitted by law.
