**NAME:** The name of this corporation is

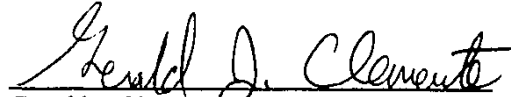

## ARTICLE X

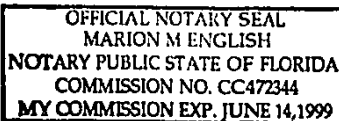

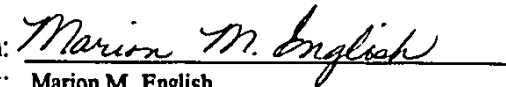
