ARTICLES OF INCORPORATION

OF

WE, the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of the Corporation shall be---SFA ENTERPRISES AND INVESTMENTS, INC.
