(MetroLink) in Melbourne, Florida. I accepted the position of Director of Regulatory Affairs for DURO in June of 2000.


I am writing this letter on behalf of our acquired CLEC entity, MetroLink. Upon calling the Secretary of States Office to get the Charter Number on file for MetroLink, I was told the Charter had been dissolved as of 9/22/00 for non-payment of the annual report fee that was due May 1, 2000. According to the Corporations Division, the reminder and request for this fee was mailed to 1600 Sarno Road, Suite 214, Melbourne, FL. I have since learned that there are no employees at that location to receive and pass mailings to our corporate headquarters in Casselberry, Florida.
