
We are writing on behalf of the above taxpayer regarding their 2000 Uniform Business Report (the Corporate Annual Report). The taxpayer just received a Notice indicating a fee due in the amount of \$750 for Application for Reinstatement. The taxpayer acknowledges the Report is being filed after the original May 1, 2000 due date, but respectfully requests you accept the enclosed check for \$150 and remove the additional late filing penalty.

The original mailing of the form was mailed to the Taxpayer's personal residence location. The Taxpayer has been out of the country for months at a time and relies on a young family member to collect the mail. The young family member gathered all the mail, but did not open any of it. When the Taxpayer returned from overseas, he immediately forwarded this notice to us. The Taxpayer has changed the mailing address on the enclosed form to our accounting firm, so that we may make sure the 2001 Uniform Business Report is filed in a timely manner.

Please abate any late filing penalties. This was an unusual circumstance. We understand the need for the State to enforce compliance of their laws by means of a penalty provision. The fundamental reason for having penalties is to support and encourage voluntary compliance. Had the taxpayer been aware of the filing requirement, they most certainly would have timely filed the Report. We have added the Report to our due date list so that we can remind the taxpayer next year and ensure they timely file the report.

The taxpayer greatly appreciates your consideration in this matter. We apologize for any inconvenience this has caused.
