ARTICLES OF INCORPORATION

OF

SUPER CARE, INC.

ARTICLE I-NAME

The name of this corporation is **SUPER CARE, INC.**

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

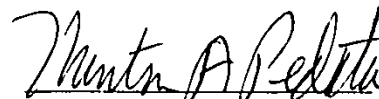
