I have been requested by the owner of this small corporation to write on his behalf regarding his corporation's status with the State of Florida. This corporation was formed in May 22, 1997, but had no financial activity until the 1998 calendar year. Our firm was first engaged to do the 1998 corporate income tax return during January 1999. All of the appropriate corporate income tax returns were timely filed during February 1999.

I asked the taxpayer to be on the lookout for his 1999 Corporate Annual Report. During May the taxpayer was in my office and I mentioned the Corporate Annual Report. He responded that he never saw one. At this point, I don't know for sure if he actually received one and mailed it in. As a safety precaution, I typed a blank form and have enclosed a check for \$ 150.

The address on the form enclosed is the proper one to mail next year's report form. Please let us know if you might need any additional documentation.
