#### ARTICLES OF INCORPORATION

OF

#### CAFE TANNINO, INC.

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

# ARTICLE I. Name of Corporation

The name of this Corporation shall be CAFE TANNINO, INC.

#### ARTICLE II. Nature of Business
