The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address. The name of the Corporation is: EAST COAST WELLS & PUMP SERVICES, INC. and its address is: P.O. Box 204, St. Augustine, Florida 32085-0204.

<u>Article 2. Duration</u>. The duration of the Corporation is perpetual.
