**FIRST:** The Article of Incorporation for the Corporation were filed on May 21, 1997 and assigned Florida document number P97000045579.


**SECOND:** The name of the Company shall be amended to:

8. The LLC shall file Articles of Amendment to the Articles of Organization of the LLC (the "**LLC Amendment**") with the Secretary of State of the State of Florida to change its name to "East Coast Wells & Pump Services, LLC."
9. The Corporation Amendment and the LLC Amendment shall be filed simultaneously with the Secretary of State of the State of Florida and the Corporation Amendment and the LLC Amendment shall be effective as of the date such document is filed with the Secretary of State of the State of Florida.
10. The Corporation requests that the Florida Division of Corporations release the name "East Coast Wells & Pump Services" so the LLC may use such name or any variation of the name.
