Enclosed please find a completed Application for Reinstatement for Advanced Geological Services, Inc. of Florida, a copy of the Profit Corporation Annual Report, and a check in the amount of \$150.00.

I spoke with a Mr. Tyrone Scott from the department that handles reinstatement matters. I explained to him that on two previous occasions I had sent the Profit Corporation Annual Report with a check in the amount of \$150.00. The first time was April 24, 1998, prior to the May 1 deadline. When this check did not clear the bank in July, I called down to your offices and was told to send another payment because they had problems processing certain returns. I sent another report and check on July 17 and this check has not cleared the bank. Mr. Scott stated that I should fill out the reinstatement form, forward a check in the amount of \$150.00, and ask for a one time waiver of late fees.

I would appreciate you granting my company the waiver of late fees as you can see I have tried to pay the annual fee on two previous occasions. We are a startup company that will only do about \$25,000 in sales for the year. The additional fees would be a significant hardship on the company. In addition, part of the problem may stem from the fact that we moved our offices during the year.
