

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation is OLSEN INDUSTRIAL SALES, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CAPITOL STOCK



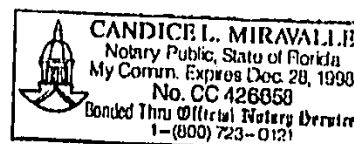
