# ARTICLES OF INCORPORATION OF HELP NOW, INC.



THE UNDERSIGNED, acting as sole incorporator of HELP NOW, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

# ARTICLE I

#### <u>Name</u>
