Mase Mebane & Briggs, P.A. (the "Firm") amends its previous Articles of Incorporation to amend the number

and classes of share issued. This amendment replaces Article IV of the December 9, 2005 Amendment

with respect to the classes of shares issued. The corporation is authorized to issue three (3) classes of stock: (a) Class A,

(b) Class B, and (c) Class C. The corporation is authorized to issue 1,000 shares of each class of stock.

This amendment replaces Article V of the December 9, 2005 Amendment with respect to the voting rights of the

classes of shares. The three classes of stock in the corporation shall have the following voting rights:

(a) Class A - full voting rights (one vote per share), (b) Class B - no voting rights, and (c) Class C - full voting rights

(one vote per share).
