ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I  
NAME

The name of this corporation is MULTI-TECH DIAGNOSTIC TECHNOLOGIES, INC.

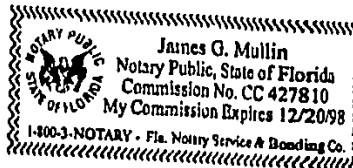
