ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - IDENTIFICATION

The name of the corporation shall be:

TETRAD Services Unlimited, Inc.

ARTICLE II - PRINCIPLE OFFICE

The street address of the principle place of business and mailing address of the Corporation is 400 West Airport Drive #4, Sebastian, Florida 32958-3926.

ARTICLE III - SHARES

The aggregated number of authorized capital stock of the Corporation is One Thousand (1000) shares, all of which having a Par Value of one dollar (\$1.00). All or any part of said shares may be issued by the Corporation from time to time and for such consideration as may be determined upon or fixed by the Board of Directors, as provided by law.
