ARTICLES OF INCORPORATION OF Katryna's Creations, Inc.



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE 1. NAME

The name of the corporation shall be: Katryna's Creations, Inc.

The principal place of service shall be 8459 W Mcnab Road, Tamarac, Florida 33321.

ARTICLE 11. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
