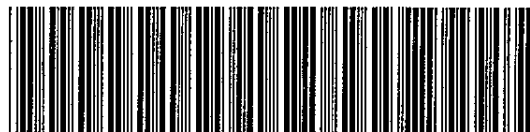

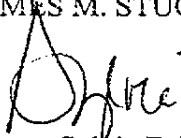

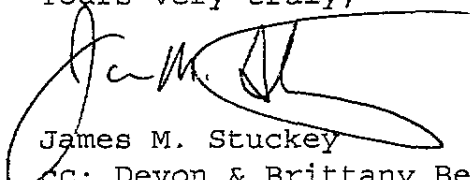
Dear Sir/Madam:

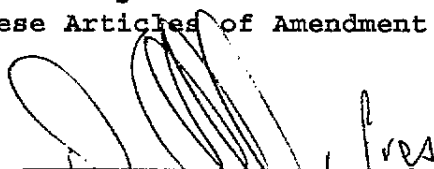
Article I, be and it is hereby amended to read as follows:

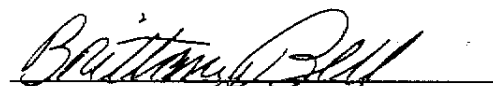
"The name of this corporation is:
