

**THE UNDERSIGNED**, acting as sole incorporator of **CINTRON AND ASSOCIATES, P.A.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
NAME and PURPOSE**

The name of the corporation is **CINTRON AND ASSOCIATES, P.A.** and the purpose of the corporation is the practice of medicine.

**ARTICLE II  
SHARES**

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, one cent (\$.01) par value per share.




