**ARTICLE I
NAME**

The name of the Corporation is **NET POINT SERVICES CORPORATION**. The principal place of business and mailing address of the Corporation is 11440 N. Kendall Dr. Suite 201, Miami, Florida 33176.

**ARTICLE II
TERM OF CORPORATE EXISTENCE**
