

# **ARTICLE ONE**

Name of Corporation. The name of this corporation shall be Sister's Care, Inc. and the principal corporate office address is 2708 7th Avenue East, Palmetto, Florida, 34221.

#### **ARTICLE TWO**

General Nature of Business. This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida for which corporations may be organized under the laws of the State of Florida.
