The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the Laws of the State of Florida.

ARTICLE ONE: NAME

The name of this corporation is AUTOMAX AUTOMOTIVE GROUP, INC.

ARTICLE TWO: NATURE OF BUSINESS

This corporation is being formed for the purpose of buying, selling, renting, leasing, repairing, and renovating all types of automobiles, boats, and trucks; and further to exercise all those powers granted by Law, including but not limited to the following:


