## ARTICLE I. NAME AND ADDRESS

The name of this corporation is ParalegalNet, Inc., and the address of the corporation shall be 405 Central Avenue, Suite 600, St. Petersburg, Florida 33701.

## ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

The date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

## ARTICLE III. DURATION

This corporation shall exist perpetually, commencing on the date of the subscription and acknowledgment of the Articles of Incorporation.

## ARTICLE IV. PURPOSE
