**THE UNDERSIGNED**, acting as sole incorporator of Eagle Trust, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name and Office**

### **Preemptive Rights Granted**


Each shareholder of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation.

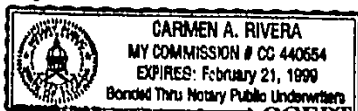
