Re: Gray Myers, Inc.

On Friday, October 13, 2000 I received a notice that Gray Myers, Inc. had been administratively dissolved for failure to file its 2000 corporation annual report. Needless to say, I was surprised to receive this notice because **I filed this report, and submitted \$150.00 on March 17, 2000 (check 1442)**. In response to the notice, I immediately pulled all of my bank statements to locate the cleared check, and found that in fact, the check never cleared. I had made a note on my March bank statement to follow-up on that check and one other item that did not clear on the March 2000 statement. However, I neglected to perform an effective follow-up, and did not realize that the check never cleared the account.

I spoke with Leslie, one of your phone representatives in the Reinstatement Section of the Florida Department of State today. **She advised me to explain the situation in writing, and submit the Reinstatement Application along with another \$150.00 check.** I also mentioned to Leslie, that the inside sheet of the Reinstatement package indicates that a notice was sent by June 9th, to each corporation at risk of being dissolved; however, I did not receive the notice at our corporation's address. Had I received a notice, it would have prompted immediate action. I do regret that I did not perform an effective follow-up on the check I originally submitted with the annual report filing; and I apologize for my ineffectiveness in keeping on top of the situation.
