



The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be:

DEXTER CONSTRUCTION SERVICES, INC.

The address of the principal office of this corporation shall be: 805 E. Shell Point Rd., Ruskin, Florida 33570, and the mailing address of the corporation shall be the same.

ARTICLE II - NATURE OF THE BUSINESS

This corporation may engage in, or transact, any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other State, Country, Territory or Nation.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any one time is 100 shares of common stock, having a \$1 par value per share.

ARTICLE IV - ADDRESS

The street address of the initial principal office of incorporation will be: 805 E. Shell Point Rd., Ruskin, Florida 33570; the name of the Registered Agent of the Corporation is Thomas J., Sherwood; the address of the Registered Agent is 3034 S. R. 674, Ruskin, Florida 33570.

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI - DIRECTORS

This Corporation shall have one (1) director initially. The number of directors may be increased or diminished, from time to time, by a majority vote of the stockholders, but it shall never be less than one (1).
